



## Preservation S.O.S Application

***About the program:***

Preservation S.O.S is a program that involves selection of a historic shotgun-style home for exterior renovation to highlight and promote renovation of the existing housing stock in Louisville. Preservation Louisville, Inc. will work with the selected owner of a shotgun home and teach them about how to maintain their property and restore its historic significance, identify exterior renovation measures that preserve the historic character of the home, and provide donated materials and labor for the renovation. The program will involve not only the property owner but also volunteers and participants from Preservation Louisville’s “Hands on History” program, which teaches maintenance and restoration techniques by highlighting a different preservation trade every month. This program is aimed at connecting the community to a rich part of its heritage, shotgun houses. The program is limited to exterior repairs. We hope to help low or moderate income homeowners rehabilitate their homes, teach volunteers practical restoration skills, and inspire a community to treasure its historic housing stock. Preservation Louisville, Inc. will review all applications and make a final selection of program participants, in its sole judgment, based on the merits of the proposed projects and their potential to highlight and promote rehabilitation of shotgun houses in the Louisville community.

***How can I get my home repaired?***

You are eligible to apply for participation if you meet three guidelines: need, project scope, and willingness to partner.

**1. I have need:**

- I own the home proposed for restoration and it serves as my primary residence.
- **My home is located in Jefferson County, Kentucky.**
- My household income falls within the following guidelines:

**2. The work on my house is within the project scope:**
